Pharm.) course regulations ,2014 No.: 14-136/2014-PCI dated 10th December 2014-in exercise of the powers conferred by section 10 and 18 of the Pharmacy Act, 1948 (8 of 1948), The pharmacy council of India, with the approval of the central Government hereby makes the following regulations: (Durations, Minimum eligibility criteria for admission, Approval of the authority conducting the course of study, Work load distribution, evaluation and examination scheme, complete syllabus and eligibility for promotion to next class etc. Is attached herewith for reference)
