
To discuss and consider for approval the syllabus and scheme of examination of B.Sc Microbiology

Therefore, the syllabus effective from session 2016-17, scheme of examination and the teaching schedule is submitted before the members of Board of Studies for approval.

The university established the Department of Environmental science in 2014 being mandatory for taking up environmental studies as one of the subjects in all the undergraduate courses of the university as per the guidelines of the UGC. To give a further boost to the department of Environmental Science it was felt that a M.Sc course in Environmental Science be introduced from the session 2017-18. The syllabus, scheme of examination and the teaching schedule has been prepared and submitted before the members of Board of Studies for approval.

To consider and approve the eligibility for admission to Diploma (MLT/RIT/OTT), B.Sc Microbiology and M.Sc Environmental Science.

A. Eligibility in Diploma in MLT/RIT/OTT

The eligibility for admission to various diploma courses in the faculty of Allied health sciences so far has been 10+2 pass in any discipline. However it was felt that the students with background other than science found it difficult to learn, pass the examination and acquire the required skills in their respective fields. Therefore it was decided to fix the eligibility for the programmes as under :

DMLT	10+2 pass (PCB) with English as one of the subject
DOTT	10+2 pass (PCB) with English as one of the subject
DRIT	10+2 pass (PCB/M) with English as one of the subject

B. Eligibility in B.Sc Microbiology

10+2 pass (PCB/M) with English as one of the subject with minimum 45% marks (40% in case of SC candidates of Haryana state)

C. Eligibility in M. Sc. Environmental Science

Must have passed B. Sc. (Environmental Science / Life Sciences / Physical Sciences / Bioscience / Biotechnology / Agriculture) or equivalent related disciplines with at least 50% aggregated marks.

The eligibility of aforesaid various programme will be incorporated in the ordinance of Faculty of Allied Health Sciences.
