

As per the communication received from the Office of the Controller of Examinations dated 29.07.2022 regarding Review Committee Meeting (photo copy of the letter enclosed for reference), the meeting was held in the Office of Controller of Examinations on 30.07.2022 at 02.15 p.m. which was attended by the following members:

The Committee discussed the matter in detail. It was observed that the discrepancy in the paper of Physiology was at two levels. The student was served the Physiology paper - II on the examination date of Physiology paper - I and Physiology paper - I on the examination date of Physiology paper - II. While going in further detail it was found that two sets of both the papers were moderated by one of the faculty member of FNYS and while moderating the papers all four papers were mentioned as paper - I. Out of these four papers two were wrongly marked as Physiology paper - II whereas they belong to Physiology paper - I.

In the prevailing circumstances, the Committee is of the opinion that there is no fault at the level of student and he should be given an opportunity to re-appear in the examination. The Committee, therefore, recommends that the re-examination of Physiology paper - I and Paper - II may be conducted at the earliest by the office of Controller of Examinations as per the provisions under the Ordinance of Examination of SGT University.



This is with reference to your letter date 28 April 2021and the letter received from supdt secy dated April 22, 2021 & regarding a complaint by the students that the question paper of BA LLB semester I (English I, 08050104) conducted on 16-04-2021 that the question paper was out of syllabus. For this purpose a committee was constituted to review the above mentioned question paper in the light of the syllabus.

We, the members of the review committee have reviewed the question paper in the light of the syllabus and after deliberations have arrived at the conclusion that:

- The question paper was set by and large in accordance with the syllabus except for section D wherein the style of the questions is theoretical in nature.
- In section D all the four questions are theoretical rather than practical. Generally
  the students are asked to write paragraphs, letters etc. so that their writing skills
  may be evaluated, whereas in this question paper the students were supposed to
  provide theoretical answers. In this respect the questions set in this section were
  beyond the expectations of the students.
- It is pertinent to mention that section D carries 24 marks out of 60.
