ABHIJAY CADTECH is a Computer Aided Designing & Computer Aided Manufacturing (CAD CAM) unit for dental Prosthesis at SGT University, Faculty of Dental Sciences.

As a part of the start-up in the first phase ABHIJAY CADTECH plans to set up a manufacturing unit for dental prosthesis on order to cater to the prosthetic requirements of the population in & around the university & Jhajjar, especially patients undergone resection of jaws due to trauma or carcinomas, wherein conventional fabrication is not possible.

Each module has an Arduino UNO that modulates the frequency of light for transmission, the Arduino receives this modulation and converts it into the proper data format for reception.

MD Electric mobility solutions are becoming increasingly popular as people seek to reduce their carbon footprint and combat climate change.


There are two main approaches to MD electric mobility solutions:

The objective of the project is to devise a combined form of a portable axillary crutch, elbow crutch and cane. Currently available crutches are bulky and very difficult to carry especially when one needs to travel on a two-wheeler, also it is difficult to locate the crutches in darkness. In certain medical conditions, a patient may need to start with an axillary crutch later progressing to an elbow crutch, and then a cane, therefore he needs to buy all three of them depending on progression. The material used makes it easy to carry and light weight, radium tape patches help to locate crutches in dark. The crutch is designed in such a way that it can be molded according to the user's progression. The base conserves energy and enhances propulsion. This base has a large contact surface to the ground, increasing the base of support followed by stability when walking on uneven surfaces. Once the patent gets approved the portable crutch will be mass produced, hence reducing the effective sales cost. Also, the crutch design will be aimed at all four designs.

Learning outcomes of the project-To gain knowledge about ambulatory devices and their functioning. To manage the healthcare need of people with ambulatory disabilities.

Novelty in the project-The crutch is designed in a way that it is easily modifiable to become an elbow crutch or cane from an axillary crutch. Making it highly cost-effective.

During an asthma attack, patient is unable to follow the command, so wearing this mask and patient is exhale in a whistling position it creates a positive end expiratory pressure as a result it helps to prevent the collapse of the alveoli in the lungs and leads to relieve the symptom of dyspnea at the same time pursed lip breathing mask we monitor the individual respiratory rate through the device circuit which is attached to it. Sensory advanced technology (respiratory rate monitor sensor is inserted into mask layer) has been used to monitor patient respiratory rate and give extra comfort to the patient. In addition, as per N95 mask it allows maximum face covering for protection. Pursed lip breathing mask has attracted the different sector such as IPD in hospital, cardiopulmonary rehab clinic and own individual use in home.

We are excited to confirm that based on our several internal discussions with you, other stakeholders and based on multiple meetings with the founders of various startups, Letters of Intent for Onboarding as Incubatees (subject to formal Agreement to be formalised in due course) have been issued (with due approval from CEO of SGTU Community Innovation Centre) and hence firmly commence incubation journey for emerging startups.

1. Base Camp Skill Labs

It is Base Camp Skill Labs at SGT University's Community Innovation Centre.

The founders of the startup are excited to be part of the incubation journey at our campus. As a part of independent Cohorts, in the current phase (Dec - Jan), Base Camp Skill Lab plans to leverage SGT University and Jhajjar's talent pool to fine-tune the product flow and value proposition.

Following are key steps in this phase:

1. Inviting the registrations for BootCamp. (Link for registration - <https://forms.gle/EaLk9nn5C3FTyHyc8>) - expecting around 100 applications.
2. First assessment - Funnel is expected to reduce to 20-30 applications
3. Learning BootCamp and Skill Assessment - 15 applications are expected to complete the BootCamp, and the camp outline is attached as a PDF document
4. Exposing the candidate to hiring partners - The startup has 5 companies actively hiring and 20+ on the list. The startup continues to build this number for the next one month before exposing the current batch.
