### Constitution of CLC's Ethics Committee

The CLC's Ethics Committee is constituted in consultation with the competent authorities.

#### Purpose

The CEC has been established to formalize and specify the Department's commitment to promotion of high ethical standards in research, and teaching.

#### Mandate

The CEC functions independently for maintaining consistent ethical framework in research, and in the integration of ethical values into practice, policy relationships, and organizational activities.

1. The purpose of CEC is to cultivate a pluralistic and democratic exchange of ethical values, concerns and to critically analyze them looking for opportunities to enhance the ethical integrity of the department.
2. The mandate of CEC, essentially targets ethical aspects of research and education.

The terms of reference for the CEC are as follows:

1. To ensure that all proposed research projects conform to standard national and international ethical guidelines and that dignity, right and wellbeing of research participants is protected.
2. To initiate and commission research studies on ethical aspects of practice in CLC.
3. Continuing education in research and ethical aspects of English Literature and Language by seminars, workshops and interactive discussions for all categories of staff members.
4. The Ethics committee endeavors to produce guidance on a broad range of topics.
5. Assessments of risk benefit ratio, informed consent process etc. are some examples.
6. The committee does not address or interfere in matters of an administrative nature, nor does the committee function as a grievance cell for staff members.

#### Responsibility

CEC has responsibility within the institution with the following objectives:

1. To ensure the competent review and evaluation of all ethical aspects of research projects received, to ensure compliance with the appropriate laws and safeguard welfare of subjects.
2. Education of professional, administrative, and support staff about ethical issues.
3. Creation, developing revising and implementing ethical guidelines (SOPs).
4. Initiate studies in ethics.
5. Continuing education and training programs to ensure that CEC members are qualified to perform their specific duties.

## Composition

CEC will be multidisciplinary and multi-sectorial in composition. It will comprise of a Chairperson, Member Secretary, and 7-13 active members who represent an appropriate balance of professional, ethical, legal, cultural, educational, and community interests. The committee will have a minimum of 7, and maximum of 13 members. The members are selected to have an equitable representation of all specialties and gender. Members are expected to be aware of local, social and cultural norms, as this is the most important social control mechanism.

3. Review progress reports and monitor ongoing studies.
4. Maintain confidentiality of the documents and deliberations of the CEC meetings.
5. Declare conflict of interest, if any.
6. To carry out work delegated by Chairperson and Member Secretary.

1. The registration is valid for a period of five years from the date of its issue, unless suspended or cancelled by the Central Licencing Authority. Provided that if the application for renewal of registration is received by the Central Licencing Authority ninety days prior to the date of expiry, the registration shall continue to be in force until an order is passed by the said authority on such application.
2. This certificate is issued to you on the basis of declaration/submission made by you.
3. Composition of the said Ethics Committee is as per the Annexure.
4. No clinical trial or bioavailability or bioequivalence protocol and related documents shall be reviewed by an Ethics Committee in meeting unless at least five of its members as detailed below are present in the meeting, namely:-
  - (i) medical scientist (preferably a pharmacologist);
  - (ii) clinician;
  - (iii) legal expert;
  - (iv) social scientist or representative of non-governmental voluntary agency or philosopher or ethicist or theologian or a similar person;



(v) lay person.

5. The Ethics Committee shall have a minimum of seven and maximum of fifteen members from medical, non-medical, scientific and non-scientific areas with at least,

(i) one lay person;

(ii) one woman member;

(iii) one legal expert;

(iv) one independent member from any other related field such as social scientist or representative of non-governmental voluntary agency or philosopher or ethicist or theologian.

6. One member of the Ethics Committee who is not affiliated with the institute or organization shall be the Chairperson, and shall be appointed by such institute or organization and one member who is affiliated with the institute or organization shall be appointed as Member Secretary of the Ethics Committee by such Institute or organization.

7. The Ethics Committee shall consist of at least fifty percent of its members who are not affiliated with the institute or organization in which such committee is constituted.

8. The committee shall include at least one member whose primary area of interest or specialisation is non-scientific and at least one member who is independent of the institution.

9. The Ethics committee can have as its members, individuals from other Institutions or Communities, if required.

10. Members should be conversant with the provisions of New Drug and Clinical Trials Rules, 2019, Good Clinical Practice Guidelines for clinical trials in India and other regulatory requirements to safeguard the rights, safety and well-being of the trial subjects.

11. The members representing medical scientists and clinicians shall possess at least post graduate qualification in their respective area of specialization, adequate experience in the respective fields and requisite knowledge and clarity about their role and responsibility as committee members.

12. As far as possible, based on the requirement of research area such as HIV, Genetic disorder, etc., specific patient group may also be represented in the Ethics Committee.

13. The Ethics Committee may associate such experts who are not its members, in its deliberations but such experts shall not have voting rights, if any

14. No member of an Ethics Committee, having a conflict of interest, shall be involved in the oversight of the Clinical trial or bioavailability or bioequivalence study protocol being reviewed by it and all members shall sign a declaration to the effect that there is no conflict of interest.

15. While considering an application which involves a conflict of interest of any member of the Ethics Committee, such member may voluntarily withdraw from the Ethics Committee review meeting, by expressing the same in writing, to the Chairperson. The details in respect of the conflict of interest of the member shall be duly recorded in the minutes of the meetings of the Ethics Committee.

16. Any change in the membership or the constitution of the registered Ethics Committee shall be intimated in writing to the Central Licencing Authority within thirty working days.

17. The Ethics Committee shall review and accord approval to a Clinical trial, Bioavailability and Bioequivalence study protocol and other related documents, as the case may be, in the format specified in clause (B) of Table 1 of the Third Schedule of New Drugs and Clinical Trials Rules, 2019 and oversee the conduct of clinical trial to safeguard the rights, safety and wellbeing of trial subjects in accordance with these rules, Good Clinical Practices Guidelines and other applicable regulations.

18. Where a clinical trial site does not have its own Ethics Committee, clinical trial at that site may be initiated after obtaining approval of the protocol from the Ethics Committee of another trial site; or an independent Ethics Committee for clinical trial constituted in accordance with the provisions of rule 7: provided that the approving Ethics Committee for clinical trial shall in such case be responsible for the study at the trial site or the centre, as the case may be: provided further that the approving Ethics Committee and the clinical trial site or the bioavailability and bioequivalence centre, as the case may be, shall be located within the same city or within a radius of 50 kms of the clinical trial site.



19. Where a Bioavailability or Bioequivalence study centre does not have its own Ethics Committee, bioavailability or bioequivalence study at that site may be initiated after obtaining approval of the protocol from the Ethics Committee registered under rule 8: Provided that the approving Ethics Committee shall in such case be responsible for the study at the centre: Provided further that both the approving Ethics Committee and the centre, shall be located within the same city or within a radius of 50kms of the bioavailability or bioequivalence study centre.

20. Ethics committee shall indicate the reasons that weighed with it while rejecting or asking for a change or notification in the protocol in writing and a copy of such reasons shall also be made available to the Central Licencing Authority.

21. Ethics committee shall make, at appropriate intervals, an on-going review of the trials for which they have reviewed the protocol. Such a review may be based on the periodic study progress reports furnished by the investigators or monitoring and internal audit reports furnished by the sponsor or by visiting the study sites.

22. Where any serious adverse event occurs to a trial subject or to study subject during clinical trial or bioavailability or bioequivalence study, the Ethics Committee shall analyse the relevant documents pertaining to such event and forward its report to the Central Licencing Authority and comply with the provisions of Chapter VI, New Drugs and Clinical Trials Rules, 2019.

23. The Ethics committee shall undertake proper causality assessment of SAE's with the help of subject experts wherever required, for deciding relatedness and quantum of compensation, as per condition no (22) mentioned above.

24. Where at any stage of a clinical trial, it comes to a conclusion that the trial is likely to compromise the right, safety or wellbeing of the trial subject, the Ethics committee may order discontinuation or suspension of the clinical trial and the same shall be intimated to the head of the institution conducting clinical trial and the Central Licencing Authority.

25. Ethics committee shall comply with the requirements or conditions in addition to the requirements specified under the Drugs & Cosmetics Act, 1940 and New Drugs and Clinical Trials Rules, 2019, as may be specified by the Central Licencing Authority with the approval of the Central Government, to safeguard the rights of clinical trial subject or bioavailability or bioequivalence study subject.

26. Ethics Committee shall review and approve the suitability of the investigator and trial site for the proposed trial.

27. The Ethics Committee shall maintain data, record, registers and other documents related to the functioning and review of clinical trial or bioavailability study or bioequivalence study, as the case may be, for a period of five years after completion of such clinical trial.

28. Funding mechanism for the Ethics Committee to support their operations should be designed and approved to ensure that the committee and their members have no financial incentive to approve or reject particular study.

29. SOP's for funding of the Ethics committee in order to support their operations must be maintained. The records of income & expenditure of Ethics Committee shall be maintained for review and inspection.

30. The Chairman of Ethics Committee shall enter into MOU with head of institution, that necessary support and facilities and independence will be provided to Ethics Committee and their records will be maintained.

31. The Ethics Committee shall allow any officer authorized by the Central Licencing Authority to enter, with or without prior notice, to inspect the premises, any record, or any documents related to clinical trial, furnish information to any query raised by such authorized person, in relation to the conduct of clinical trial and to verify compliance with the requirements of these rules, Good Clinical Practices Guidelines and other applicable regulations for safeguarding the rights, safety and well-being of trial subjects.

32. Where Central Licencing Authority is of the opinion that Ethics Committee fails to comply with any provision of the Drugs and Cosmetics Act, 1940 and New Drugs & Clinical Trials Rules, 2019, it may issue show cause notice to such Ethics Committee specifying therein such non-compliances and the period within which reply shall be furnished by such Ethics Committee. After consideration of the facts and reply given by the Ethics Committee, the Central Licencing Authority may take one or more actions specified under provision of Rule 14, Chapter III of New Drugs and Clinical Trials Rules, 2019.

## **Status of research protocols submitted by MD / MS and PhD candidates**

### **1. MD/MS candidates**

A total of 55 research protocols submitted by students enrolled for the MD / MS courses, session 2020, were screened by Screening Ethics Committee (SEC) out of which a total of 50 protocols were approved by SEC in its meeting held on 15<sup>th</sup>, 18<sup>th</sup> and 21<sup>st</sup> December, 2020 and 5 protocols that contained issues like drug trials were forwards to IEC. These 5 Protocols were considered in the meeting of IEC held on 01.03.2021 and 02.03.2021 and were approved by IEC in the meeting.

**Thus all the protocols submitted by MD / MS candidates for consideration by IEC stand approved.**

### **2. PhD candidates**

A total of 8 (eight) protocols submitted by candidates enrolled for PhD were considered by earlier IEC in its meeting held on 20.03.2020.

A total of 7 (seven) protocols were retained for further consideration following incorporation of amendments suggested by IEC. Out of the 7 protocols considered by IEC in its meeting held 01.03.2021 and 02.03.2021, 4 (four) candidates protocols were approved by IEC while for 2 (two) candidates, who did not appear for the IEC meeting, the members of IEC recommended consideration for deregistration by the university since they failed to comply with the suggestion of IEC on repeated occasions. One candidate who was absent in the IEC was given an opportunity to reappear on a subsequent meeting since the candidate appeared in the earlier IEC meeting held on 20.03.2020 in which the IEC recommended some changes.







## Consensus statement on decision of IEC on CTRI guidelines


1. CTRI registration is mandatory for any drug clinical trial / academic clinical trial. As per the amended Schedule Y (2005) of the Drugs and Cosmetics Rules, 1945, a clinical trial refers to a systematic study of new drugs on human subjects to generate data for discovering and/or verifying the clinical, pharmacological (including pharmacodynamic and pharmacokinetic) and/or adverse effect with the objectives determining safety and/or efficacy of a new drug. The academic clinical trial as per GSR 313 (E) dated 16 March 2016 (ref: clinical trials Consensus statement on decision of IEC on CTRI guidelines interventions, section 7 ICMR, 2017) is a clinical trial intended for academic purposes in respect of approved drug formulations for any new indication or new route of administration or new dose or new dosage form. An EC has to approve such studies after due consideration of benefits and risks and all other ethical aspects and the licensing authority has to be informed as per the prescribed procedures.
2. CTRI registration is to be initiated by the principal investigator.
3. Prior approval of Ethics Committee is necessary / recommended before registration with CTRI



### INSTITUTIONAL ETHICAL COMMITTEE FOR FNYS – ANNEXURE

#### 1. Purpose:

The purpose of this procedure is to identify the administrative process and provide instructions for the preparation and circulation of meeting agenda, Meeting proceedings, action taken, invitation, and notification letters of institutional Ethics Committee Ethics Committee.

#### 2. Scope:

This SOP applies to administrative processes concerning the preparation of the agenda for all regular IEC meetings, divided into three stages: before, during and after the meeting.

#### 3. Responsibility:

It is the responsibility of the Secretariat staff to prepare the agenda for the IEC meeting and to ensure the quality and validity of the minutes after the meeting is over. The Chairperson/Member Secretary should review and approve the agenda and the minutes sent to him/her.

#### 4. Detailed Instructions:

##### 4.1 Before each Ethics Committee meeting:

##### 4.1.1 Check for filled up forms for completeness - Secretariat

- Reviews the new study application for completeness
- Documents the review by completing the appropriate Checklist, if incomplete, the secretariat staff attempts to obtain the information from the investigators who submitted the application package and gets rectification done.

##### 4.1.2 Consider the appropriate review channel of each protocol

- Use the criteria and the procedures as described in the corresponding SOPs when deciding the review channel-
- SOP for Review as per ICMR Guidelines will be followed
- The protocol will be checked by IEC members and Member Secretary with the help

of Checklist in which they will assess whether the project will be considered for Review of submitted Protocols, Review of Protocol Amendments, Continuing Review of Study Protocols, Review of Final Reports and Management of Study Termination. The Principal Investigator will mention the type of review in the covering letter and will submit the documents accordingly. Principal Investigator will incorporate the suggestions given by IEC members and submit multiple copies as required to the secretariat.

- The Dossier will be sent to the IEC Members for their comments and suggestions will be discussed in the IEC meeting

#### 4.1.3 Prepare meeting agenda

- Schedule the review as soon as possible after submission, at the time of the next scheduled meeting.
- Consult the Chairperson and other IEC members to schedule the meeting date.
- Prepare the meeting agenda, according to the ICMR guidelines
- Schedule protocols in the agenda on a first-come first-serve basis.
- Inform to the IEC members regarding the meeting for confirmation purpose
- Allow at least 2 weeks for the review process.
- Specify the due date for the return of comments.
- Include a Study Assessment Form with the protocol package along with the invitation letter and the meeting agenda.
- Write down the running number of the protocol in the square boxes at the bottom right corner of the form
- Prepare the package for delivery.
- Record the name of the IEC Members in the agenda for each protocol to be reviewed.

#### **Distribution of Protocol Packages (IEC Dossiers) to the IEC Members**

- Keep in mind Procedure for Maintaining Confidentiality of IEC documents when preparing and distributing documents.
- Distribute copies of the protocol submission packages to the IEC members personally 8 days prior to IEC meeting by post/ hand given materials in the Correspondence section of the respective protocol file.
- Verify verbally with the members whether the Dossiers are received.

#### **4.2 During the Ethics Committee meeting:**

- The IEC may allow investigators, clinical collaborators, and guest attendees etc., to attend the portion of the EC meeting related to their studies.
- At the discretion of the Chairman, guest attendees (potential client, students, etc.) may be allowed to observe the Board meetings.
- Guest Attendees are required to sign a confidentiality agreement form
- The Secretariat reports on the minutes of the previous meeting and presents the agenda for discussion.
- The Secretariat records the discussions and the decisions made during the meeting.
- The Chairperson may inform members and attendees of the rules being followed during meetings.
- The meeting proceeds in the order organized in the agenda; however, the Chairperson may allow some switching depending on the situation.
- The IEC Members give their comments right after the presentation and the discussion about the study takes place.
- Investigators may be allowed to present their Protocols in brief and clarify any questions the IEC members may have.

#### **4.2.1 Decision Making:**

- Voting will be held only in cases where there is a lack of consensus on an issue/protocol.
- Voting will be by hand rising.
- In order to avoid conflict of interest, only those IEC members who are independent of the investigator and the sponsor of the trial will vote on the research-related matters.
- All voting will take place after the observers / presenters / IEC members with a conflict of interest leave the meeting room.
- The Chairman determines if the number of voting Board members is sufficient to constitute a quorum and proceeds accordingly.
- If quorum is not met then the meeting will be deferred
- An IEC member makes a motion to recommend action on a protocol or issue being discussed.

#### **4.3 After the Ethics Committee Meeting:**

- As soon as possible after each meeting, a copy of the minutes is sent to IEC members for quality control and review.
- The EC members indicate review by signing and dating the minutes.

- The Chairperson/M.S indicates approval by signing and dating the minutes.
- The Secretariat maintains the official copies of the minutes in accordance with the archiving procedures.

#### **4.4 Preparing of Meeting Proceedings and action taken:**
