Dr. Mandeep S Grewal gave the welcome address and explained the agenda of the meeting.

genda Point (i) - To examine and approve the panel of External and Internal examiners or BDS examinations 2021

 Panel of external and internal examiners for BDS examinations 2021, submitted by the subject Heads of Departments in accordance with the University norms were placed before the committee. The committee checked the panel thoroughly and approved the panel.

Agenda Point ii) - To review UG Curriculum & propose for any addition both in theory and clinical training

- Both theory and clinical curriculum as per the Dental Council of India, BDS Course Regulations 2007 Gazette including amendments, SGT University statute & UG Ordinance were discussed in relation to all dental subjects.
- Dr Shourya Tandon gave presentation on Competency based teaching and evaluation methods on the model proposed by MCI. This was agreed by all to be a futuristic proposition but more understanding through trainings and also regulatory body directions were needed for better probability of implementation.
- Then to give emphasis on implementation of New Curriculum in UG studies it was advised that following features can be added to enhance UG program:
 - 1. There must be additional 5 hr teaching by each department other than routine course.
 - 2. Special emphasis must be given to oral implantology, forensic odontology, aesthetic dentistry, laser dentistry and other latest areas of interest.
- It was highlighted the new curriculum topics may be offered as different platforms like:
 - o stand-alone additions for BDS Students
 - Value Added Courses
 - o Multi-disciplinary Courses

<u>Agenda Point III) - To review & propose to start Multidisciplinary Course in UG Curriculum in the subject of Behavioural Sciences in Health Care</u>

- From Department of Public Health Dentistry Dr. Shourya Tandon proposed to add curriculum teaching related to Behavioural Sciences for BDS Students.
- It was then discussed that in lines with the changing education policy though not notified by Dental Council of India, but still, we can proactively propose curriculum value addition for our students and to increase the reach of our teachers.
- Behavioural Sciences in Health Care, a multi-disciplinary course would be proposed for BDS students and other SGT University Health Sciences Students, to be taught by Public Health Dentistry in collaboration with Paedagle and Preventive Dentistry and other relevant stakeholders from SGT University.

 The goals, objectives, skills to be incorporated for the course were also presented and discussed.

Agenda Point iv) - To review & propose to start UG Curriculum in the subject of Ethics in Third BDS taught by Public Health Dentistry

- On similar lines as Agenda Point iii) Dr. Shourya Tandon also proposed to add curriculum teaching related to Ethics for BDS Students.
- It was then discussed that this topic too could be taken as a multidisciplinary course but to be worked on at a later date after completion of proposed course as per Agenda Point iii)
- At appropriate time Department of Pubic Health Dentistry along with other SGT University stakeholders would propose the same.

Agenda Point v) - To review & propose Value Added Courses proposed by departments of Faculty of Dental Sciences

- It was discussed that Value added courses could be another means to improve the employability aspect of our students and other students at SGT University keeping in mind the multi-disciplinary scenario.
- Dr. MS Sidhu explained the guidelines for a model Value Added course and the following value-added courses were proposed by various departments:
 - i. Photography by Department of Orthodontics
 - ii. Biomedical Waste Management by Department of Prosthodontics & Department of Oral Pathology
 - iii. Course on Microscope Enhanced Dentistry by Department of Conservative Dentistry and Endodontics

Agenda Point vi) – To change the existing Scheme of Examinations for BDS Programme as per the DCI BDS Course Regulations-2007 (Revised)

- The following to be added in the existing Scheme of Exams for BDS programme under the heading Practicals after para 6(B)(b) in accordance with the DCI BDS course Regulations 2007 (Revised):
 - (c) In case of Physiology and Biochemistry if Internal examiner is from Physiology, External examiner should be from Biochemistry or wise versa
 - (d) In case of Pathology and Microbiology, if Internal examiner is from Pathology, External examiner should be from Microbiology or wise versa

In accordance with the existing DCI BDS Course Regulations 2007 (Revised) the matter was approved in the meeting of Board of Studies.

Agenda Point vii) - To review scheme of Examination & propose for any modification in theory and clinical examination

- 1. The following was discussed:
 - (a) Dr Shourya Tandon introduced and proposed the incorporation of OSCE (Objective Structured Clinical Examination) in BDS Examinations and gave presentation on examples from Public Health Dentistry so that they could be used as an evaluation method. All department heads shared their thoughts that this could be used in their respective department examinations too.
 - (b) This was agreed by all the head of departments to be a futuristic proposition but more understanding through trainings were needed for better probability of implementation.
 - (c) Dr. Sanjeev Saxena gave his inputs on the implementation of OSCE method for evaluation in BDS examination.
 - (d) Dr. M S Sidhu explained how various universities have a stream implemented OSCE in their routine.

2. Implantation of OSCE in BDS evaluation can be done as pilot drive in all the department.

Dr. M S Sidhu suggested that we must conduct workshop on OSCE in which one senior member from each department should participate. Dr. Sanjeev Saxena and Dr, Shourya Tandon will design this workshop.

He suggested that initially to begin with 20 marks can be assigned by OSCE in final year examination.

- 3. Dr. M S Sidhu desired that each department must submit one topic beyond the curriculum above DCI, and which shall be taught in additional teaching hours.
- 4. It was suggested by Dr. Jigyasa that behaviour studies must be started for BDS 1st year Batch and Ethics must be taught in BDS 2nd year before clinical postings.

All the members agreed on all the valuable inputs received in meeting

Dr. Mandeep S Grewal concluded the meeting by closing remarks to implement all suggestions at the earliest in Faculty of Dental Sciences.
