The following resolutions were adopted and approved:

1. **Approval of Choice-based Credit system in the Faculty of law so as to synchronise with other disciplines and introduction and syllabi of the following New Optional Law Courses in the BA LLB(H) 5Yrs, BBA LLB(H) 5yrs; LLB(H) 3Yrs:-**

1. Forensic Science & Law
2. Medical Jurisprudence
3. Medico – Legal Ethics
4. Sports and the Law in India
5. Surrogacy law in India

- 2: **Approval of the reintroduction of trimester system in LL.M (which was being followed earlier)**

- 3: **Approval of the Syllabi for the Courses to be offered in LL.M 1st, 2nd and 3rd Trimester.**

- a) Reapproved the curriculum & syllabi of all papers of LL.M which were already approved for 2014-15 except the syllabus for the paper Comparative Public Law.

- b) **Approval of the revised syllabus of the paper Comparative Public Law.**

- 5: **Approval of the amendment of the Distribution of Assessment for Formative and Summative evaluation for the courses offered in BA LLB/ BBA LLB (H) 5 Yrs./ LLB (H) 3 Yrs. i.e. 40 % marks for formative (Internal) assessment and 60% marks for summative (Mid – Term and End-Term) assessment.**

- 6: **Approval of: a) the setting and evaluation of End-Term examination of undergraduate courses by internal paper setter & examiners instead of external paper setter & examiners.**

- b) **Approval of Moderation of question papers and all results (including post graduates courses) by a committee appointed by the Dean, Faculty of Law.**

- 7: **Approval of Change of the name of the following subjects retrospectively.**

- a) The subject History – I is re-named as Ancient & Medieval Indian History
- b) The subject History – II is re-named as Modern Indian History

- 8: **Approval of the merger of subjects Corporate Law – I and II and renamed as Company Law w.e.f. 2018-19 and the syllabus for the same. (Schedule – III)**
