Item no.2: Changes in the name of subjects of Semesters mentioned below:

In addition to the above, some significant changes were suggested as follows:-

- 1. It was observed that there was no uniformity in the number of subjects taught BALL.B(Hons.), BBALL.B(Hons.)of semester of the LL.B(Hons.) each batch, BALL.B(Hons.), BBALL.B(Hons.), LL.B(Hons.) of 2018 batch. Therefore it BBALL.B(Hons.), was decided that the students were unnecessarily being burdened which would proved counter productive.
- 2. It was observed that the number of social science paper taught should be reduced and that after the 4th Semester for 2018, 2019 batch, there should be only law subjects taught.
- 3. 'Law of Evidence' paper (BALL.B(Hons.), BBALL.B(Hons.) VII Sem.) 2016 batch should include e- evidence. For this purpose, it was suggested that the site of 'Deptt. of Justice' should be visited.
- 4) 'Insurance Law' Paper(BALL.B(Hons.), BBALL.B(Hons.) VII Sem.) 2016 batch should include a topic on deficiency in customer relationship & Regulatory authorities. Further, the topics on fire insurance & Marine insurance should be included in one Unit.
- 5.) White Collar crime' paper (BALL.B(Hons.), BBALL.B(Hons.) VIII Sem.) 2016 batch should be renamed as 'Socio - economic offences' and topic on 'Privilege class deviance' must be included in the paper.
- 6. 'Principles of Taxation Law' (LL.B(Hons.) III Sem.) paper 2018 batch should include topics on GST & Insolvency Act.
- ~ 7. 'GATT' (BALL.B(Hons.), BBALL.B(Hons.) VIII Sem.) paper 2016 batch should be renamed as 'International Trade Law'.
- 8. 'Legal methods & Research methodology' (BALL.B(Hons.), BBALL.B(Hons.) I Sem.)2019 Batch paper should be renamed as 'Legal methods'.





- The paper of 'History-I' should be 'History-II(Legal History)' & 'History-II' can be . 'History-I' in BALL B(Hons.) from 2019 batch
 - The paper on 'Law of Tort' should be divided into 2 Papers ' Law of Tort I' & 'Law of Tort-II including Consumer Protection Act' from 2019 batch for BALL.B(Hons.), BBALL.B(Hons.), LL.B(Hons.).
 - 'Law on sales of goods & consumer protection 'paper of 4th Semester can be deleted as 'Sales of goods' can be included in 'Law of Contract- II' & 'Consumer Protection' can be included in 'Law of Tort II' from 2019 batch
 - 'Environmental Law' paper of 2nd Semester can be shifted to 4th Semester in place of 'Law on Sales of Goods & Consumer Protection' paper & Law of Torts Il' paper can be included in place of Environment Law' paper from 2019 batch for BALL.B(Hons.), BBALL.B(Hons.), LL.B(Hons.).
 - They suggested 'Constitutional Law' & 'Administrative Law' should be taught in early semesters & Procedure Codes can be taught in later semesters 13.
 - 'Professional ethics & professional accounting system' (LL B(Hons) VI Sem.) for 2018 & 2019 batches. (Professional ethics & professional accounting system to Andread Professional ethics & Bar bench relationship paper should be renamed as 'Professional ethics & Bar bench relationship'
 - 'Penology & Victimology' (LL.B(Hons.) VI Sem.) paper should be renamed as
 - Women & Criminal Law' (LL.B(Hons.) VI Sem.) paper can be renamed as 'Criminology, Penology & Victimology'.
 - 'Law of Carriage' (BBALL.B(Hons.) VIII Sem.) paper should be deleted and in Women & Law'. place of this subject, they should be taught 'Corporate Governance'.
 - IT Law' (BALL.B(Hons.), BBALL.B(Hons.) XIII Trimester) paper should include e- courts.

Item no. 3: Approval of the Revised Ordinance, Scheme of Examination & Syllabi for LL.M one year Degree Programme - 1 & II Semesters

The Revised Ordinance, Scheme of Examination & Syllabi for LL.M one year Degree Programme - I & II Semester was discussed & approved. It was decided to have LL.M (1 year) course in 2 Semesters. Following change was suggested:
