Dated September 23rd 2021 to all the Pharmacy Institutions approved by PCI and

Examining Authorities on the subject matter cited below:

Syllabus framed under Regulations 7, List of Prescribed Equipment and Apparatuses under Appendix-A of the Education Regulations, 2020 for Diploma Course in Pharmacy as per the Gazette Notification of India, Extra Ordinary No. 435, Part III, Section-4, Dated 16.10.2020. It is for implementation and strict compliance from 2021-2022 academic session

- 3. The committee members approved the appointment of faculty members for Pharm. D. and M Pharmacy for the specializations viz. Pharmaceutics, Pharmaceutical Chemistry & Quality Assurance, Pharmacology, Pharmacy Practice, Pharmacognosy as per the requirement of Pharmacy Council of India under "Minimum Qualifications for teachers in Pharmacy Institutions regulations 2014".
- 4. The Committee Members approved Updated list of Paper Setters, Evaluators and External Examiners for UG / PG / Pharm D and Other Courses for the sessions 2021-2022 and 2022-2023.
 - a. The Committee Members suggested that the External Examiners for PG program has to be either PhD or Minimum 5 years' experience in the same specialization, and preferably from institute where PG Courses are running is to be appointed.
 - b. The Committee Members suggested that Faculty members with Ph. D degree only to supervise M Pharm. Students, however faculty members having M. Pharm. / Pharm. D. degree can be Co-supervisor.
- 5. The Committee Members approved and adopted the Minutes of the meeting of Institutional Review Committee (IRC) & Departmental Research Committee (DRC) for the evaluation of M. Pharm. research Proposals. Prof. Kanchan Kohli suggested that evaluation of PG synopsis is an internal matter of the SGTCOP.
- The Committee Members approved the Introduction and evaluation of Value-Added Courses and Multidisciplinary courses (list of subjects, Syllabus, Evaluation scheme attached) at SGT UNIVERISTY by SGT College of Pharmacy
