 - 1. The trainee will not get any residential accommodation.
 - 2. No financial aid to Society/ SGT Medical College, Hospital & Research Institute, Budhera (Gurgaon) will be given.
 - Time table will be made by the Civil Surgeon, Gurgaon and will be 3. adhered to by the students of SGT Medical College, Hospital & Research Institute, Budhera (Gurgaon).
 - 4. The College Authorities will not interfere in the Administration of the Hospital.
 - 5. If any additional material have to be purchased for the use of trainees, the expenditure will be borne by the Institute.
 - The Institute/college will have to deposit Rs. Three Lac as security 6. with the Civil Surgeon, Gurgaon so that any damage or loss caused to the machinery and equipment of the hospital by the trainees or trainers, Institute/college could be recovered/adjusted against the refundable security. The amount shall have to be deposited at the time of actual commencement of the training in the above mentioned PHC and CHC.
 - An amount of Rs. 5000/- per student per annum out of the fees already received from them may be deposited in Hospital/ Government Treasury through Civil Surgeon, Gurgaon.

It is requested that as per the norms of Medical Council of India for minimum requirement of 100 MBBS admission annually regulation 1999, every medical college shall have 3 PHC/RHTC for training of students in community oriented primary health care and rural based health education to the community attached to it. One primary Health Centre/RHTC should have residential arrangement with mess facility for students, interns, which should be under the full administration control of the medical college (copy attached as annexure)

It is pertinent to mention that SGT Medical College, Hospital and Research Institute is having own Rural Health Training Center (RHTC) at village Kaliawas with hostel and mess facilities for undergraduates and interns at RHTC under its administrative control.

Request was made vide our letter No. SGT/MC/P/538 dated 24.12.2013 for attachment of 3 PHCs/CHC with this college for training of medical students in community oriented health care.

So it is again requested to attach the PHC Daultabad (Distt Gurgaon), CHC Faruknagar (Distt Gurgaon) PHC Badsa (Distt Jhajjar) for training of MBBS students in rural orientation as per MCI norms.
